Veterans Registration Reporting (VRR) Form

REQUIRED: Students receiving Veterans Administration (VA) educational benefits at Lakeland are REQUIRED to complete the VRR form EVERY semester in order to be certified. VRR forms are available at the Student Service Center and at the Lakeland's Veterans website: www.lakelandcc.edu/veterans (under "Documents & Forms")

Eligible/Payable Courses

Only courses listed on your degree tracker or listed as course requirements in the college catalog for the degree(s) you are pursuing are eligible for VA educational benefits.

If you attended another college or university prior to enrolling at Lakeland, you **must** have all official transcripts sent from the granting institution directly to the <u>Admissions Office</u> at Lakeland. Once your transcripts are received, schedule an appointment with a Lakeland academic counselor for an official evaluation of transfer credits. The VA will not pay for retaking courses that have been successfully completed at a prior institution.

The VA will pay for:

- Courses required for your degree program
- > Remedial courses if there is a documented need

> Courses repeated due to failure or if grade received does not meet degree requirement The VA will not pay for:

- > Online or Hybrid remedial courses
- > Courses in which a passing grade has already been earned
- > Retaking courses that have been successfully completed at a prior institution
- Courses not attended or pursued
- Courses withdrawn
- Courses needed at another college if you are not enrolled at that college (unless you meet specific requirements See Debbie Weber for details)

Counseling Services

Meeting regularly with an academic counselor at Lakeland is critical to ensuring you enroll in only those courses that are **required** for your degree and are eligible for VA educational benefits. Be sure to <u>schedule an appointment with your counselor</u> prior to registration each semester.

Walk-in counseling is available for less in-depth sessions.

Reminder: Spring 2017 Graduation Application Deadline is Friday, March 31, 2017

Dual Major

Students may pursue a dual major as part of a single objective. Only courses required to complete the dual major can be certified. See Debbie Weber for details.

Degree Tracker

Track your progress by using the degree audit program "Degree Tracker" available in your <u>myLakeland</u> student account. In the "Student Tab" under "Quick Tools", click on the Degree Tracker icon to view your program information, academic history, "what if" scenarios, and more.

VA Enrollment Status

For VA reporting purposes, your enrollment status (full-time or part-time) is measured by the number of semester credit hours taken in a sixteen, eight or five week session:

Policies

To continue receiving VA Educational Benefits, you must meet the college's <u>Standards of</u> <u>Academic Progress</u>, <u>Student Conduct Code</u>, and <u>Attendance</u> policies. Please be sure to review these policies located in <u>Lakeland's 2016-17 Catalog</u> and <u>Student Development Documents and</u> <u>Forms</u>.

Failure to attend class does not constitute withdrawal. To withdraw from a course, you must officially drop the course by posted withdrawal deadlines. Any time you drop or add a course, you are required to notify Debbie Weber and the VA to avoid overpayment issues.

Nonattendance has a very negative impact on your continued eligibility for educational benefits.

CAUTION: You are responsible for ALL debts resulting from reductions in your enrollment.

Tuition & Fees

You are responsible for ensuring all tuition & fees are paid by the <u>due date</u>. If your certification is delayed for any reason, you must enroll in the <u>Lakeland Tuition Payment Plan</u> to avoid being removed from your classes and affecting your eligibility for VA benefits.

Veterans Receiving Chapter 30, 1606 or 1607

In addition to the semester certifications done by Debbie Weber, Veterans Benefits Certifying Specialist at Lakeland, you are also REQUIRED to . . .

Veterans Receiving Chapter 33 Benefits

Monthly Housing Allowance (MHA)

Monthly Housing Allowance benefits are prorated and based on a "Rate of Pursuit" that is GREATER THAN 50% (rounded to the nearest multiple of 10).

EXAMPLE: Full-time enrollment is 12 or more credit hours in a 16 week session. If you enroll in 9 credit hours, your "rate of pursuit" is 75% (9 credits divided by 12 credits). 75% is then rounded to the nearest multiple of 10, which in this example is then 80%. This means you will receive 80% of your applicable MHA rate.

- Online classes: MHA for ALL online classes is \$754.50.
- Zip Code: MHA for Lakeland's zip code (44094) is \$1,426.00

Post-9/11 GI Bill Recipients (Chapter 33): VA Debt Management Center

If you have been notified by the Department of Veterans Affairs Debt Management Center that your VA Education Benefits for Lakeland Tuition and Fees were adjusted and a debt was created, please contact Lakeland's Business Services Office at 440-525-7008.

Inquiries

Lakeland certifies enrollment information according to VA regulations. Lakeland cannot provide information regarding your VA educational benefit payments.

▶ Benefits are usually paid the first week of each month; payment will be based on the previous month's verified enrollment. Be sure to update your address or direct deposit information via the <u>WAVE</u>, or by calling 1-888-442-4551.
